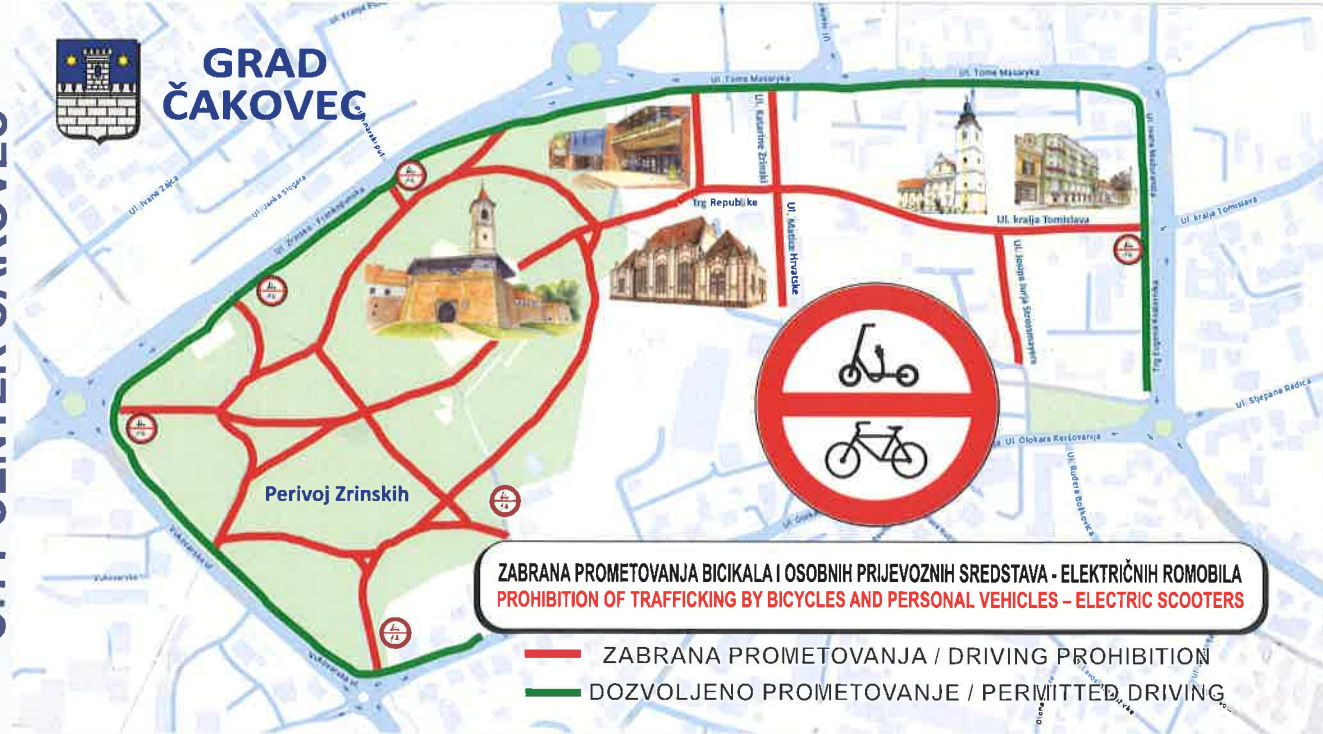

**ZABRANA PROMETOVANJA BICIKALA I OSOBNIH
PRIJEVOZNIH SREDSTAVA - ELEKTRIČNIH ROMOBILA**

Na području „Pješačke zone“ i parka „Perivoj Zrinskih“ ZABRANJENO JE prometovanje biciklima i osobnim prijevoznim sredstvima – električnim romobilima, osim u sljedećim slučajevima:

- * kada su ta prijevozna sredstva prenamijenjena za posebne svrhe kojima se koriste osobe s invaliditetom,
- * kada ta prijevozna sredstva koriste službene osobe Hrvatske pošte tijekom obavljanja službenih poslova.

Prometovanje biciklima i osobnim prijevoznim sredstvima - električnim romobilima uz park „Perivoj Zrinskih“ dopušteno je samo rubnim dijelovima parka, odnosno asfaltiranim stazama uz Zrinsko-Frankopansku i Vukovarsku ulicu. Molimo za razumijevanje i poštivanje propisane odluke. Nepoštivanje zabrane podliježe propisanim sankcijama.

**PROHIBITION OF TRAFFICKING BY BICYCLES AND
PERSONAL VEHICLES – ELECTRIC SCOOTERS**

In the area of the “Pedestrian Zone” and the “Perivoj Zrinskih” park, the circulation of bicycles and personal means of transport – electric scooters is PROHIBITED, except in the following cases:

- *When these means of transport are repurposed for special purposes used by persons with disabilities,
 - *When these means of transport are used by officials of the Croatian Post during the performance of official duties.
- Trafficking by bicycles and personal means of transport – electric scooters is allowed only in the peripheral parts of the “Perivoj Zrinskih” park, i.e. on the paved paths along Zrinsko-Frankopanska and Vukovarska streets.

We ask for your understanding and respect for the prescribed decision.
Failure to comply with the prohibition is subject to the prescribed sanctions.
